| Dependents (with legal documents) | Spouse, parents, parents-in-laws, children, step children, adopted children (all <35 years old). No age limit for disabled children. Same gender marriage not allowed. | | | | |

| Change of Principle Applicant | MM2H is transferable to next-of-kin in the event of the passing of the main applicant. | | | | |
| MM2H Renewal (Every 5 years) | Documents required (1) valid passport, (2) medical report (3) medical insurance. It will be processed by MM2H Center/Malaysian Immigration. | | | | |
| Government renewal fee (per application) | 5,000 | 3,000 | 1,500 | 300 | |

Even for Platinum and Gold, the visa given is on a 5-year block as the Immigration wants to check if the 90-day requirement is fulfilled
